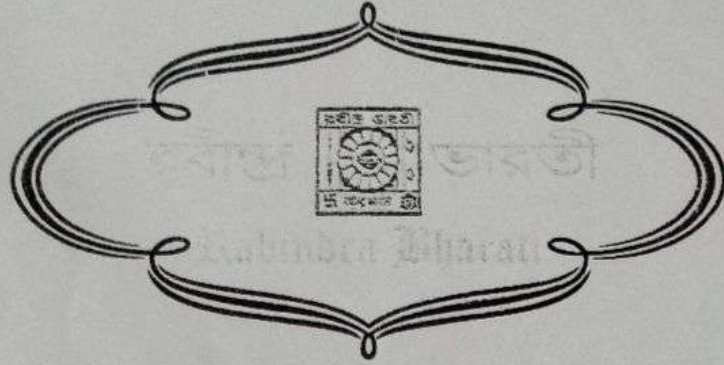

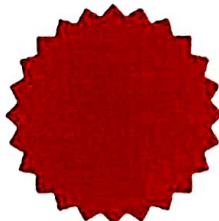

With reference to your application for admission to the Ph.D. programme on the topic entitled above and your subsequent performance in defending the synopsis before the Higher Degrees Committee in the seminar held for the purpose, you are hereby informed that you have been / have not been permitted by the University to get yourself registered at the Ph.D. programme on the said topic / you have been advised by the University to revise the synopsis in the line suggested below and apply a fresh in the prescribed manner together with the synopsis so revised within six months hence.

You are now requested to register yourself at the said programme on payment of the Registration Fee of Rs. (100) in cash and on production of the Marksheets and Certificates of the examinations passed, all in original, within two months of the date of issue of this letter. If you are migrating from another University you will have to submit the Migration Certificate from the said University at the time of your Registration and to pay an additional sum of Rs..... towards Immigration fee. Foreign students will further be required to produce Passport, Visa, Security Clearance from the Ministry of Home Affairs, Govt. of India, and approval of the Department of Education, Ministry of Human Resource Development, Govt. of India. They would also be required to pay the Facilitation fee of Rs. 4000/- in addition to the Registration fee at the time of registration and all supporting documents in original.

It may be noted that your registration will remain valid for four years from the date on which your registration fee will be deposited with the University. The period may, however, be extended by one year more subject to fulfilment of certain conditions prescribed in the relevant Regulations. The thesis will have to be submitted during the period the registration remains valid but after completion of two years registration.

On completion of the research work, you will have to submit to the University four copies of the thesis accompanied by the Certificate of the supervisor (s) in a prescribed form and the requisite fee. The thesis shall be typed or photocopied or printed for the purpose of submission and bound with cover and title pages in the format prescribed. The cover and title pages shall contain the title of the thesis at the top, then the words. "Thesis submitted for the Degree of doctor of Philosophy of Rabindra Bharati University" towards the middle and then name of the candidate at the bottom.

A Candidate cannot submit any work as his/her thesis for the Ph. D. degree for which a degree or diploma or any other academic award has already been conferred on him.

It may also be noted that your registration shall be subjected to the provisions of the relevant Regulations / Rules of the University as may be in force from time to time.

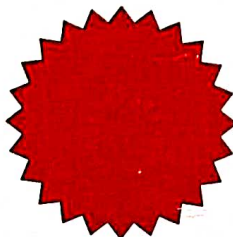
